Part D. General Information

- A Special Defence Event Exemption is issued for the length of the event.
- A Special Defence Event Exemption cannot be renewed.
- A Special Defence Event Exemption is valid for possession of specified weapons only.
- All persons wishing to be classified exempt must complete Part B of the application.
- All applicants must include a copy of their current Firearms Licence (with photo ID), current Drivers Licence (with photo ID) or current Passport to accompany this application.
- Special Defence Event Exemptions involving a B709 Importation Permit must include the pre-arranged pickup date given to them by Australian Border Force, and include full details of how the weapons will be delivered, and where the weapons will be stored for the duration of the event, and how the weapons will be removed from Western Australia.
